e-Rental

ASLE's e-Rental is an online booking application on www.asle.com.au that allows our customers to browse through our hire inventory and make a booking online.

Pricing

Pricing in e-Rental is subject to change without notice, and the price estimate given by the application should only be used as a guide. Pricing will be confirmed in the booking confirmation sent from All Sound & Light Entertainment Pty Ltd's Hire Department after the customer has requested the booking.

Availability

All equipment is subject to availability and is not confirmed until the customer has received a booking confirmation from All Sound & Light Entertainment Pty Ltd's Hire Department. For hire's where the total amount is greater than \$200 including GST a 30% deposit will be required before equipment is confirmed.

Booking Confirmation

The customer will receive an email stating that the rental request has been received by All Sound & Light Entertainment Pty Ltd. This is not to be taken as being a booking confirmation. A member of staff from All Sound & Light Entertainment Pty Ltd will email the customer within 48 hours of the request being made with a Booking Confirmation to advise the customer that the booking has been confirmed with All Sound & Light Entertainment Pty Ltd. If the customer has not received a booking confirmation within 48 hours of making the request we advise to contact All Sound & Light Entertainment by telephone and quote their booking reference to follow up.
